- Amphetamine Salt Combo 10mg increased from \$0.3548/tab to \$0.9427/tab effective 10/27/11.
Triamcinolone Ointment 0.1% increased from \$0.1246/g to \$0.2631/gram effective 10/27/11.
Metronidazole 500mg increased from \$0.2381/tab to \$0.5920/tab effective 10/27/11.
D-Amphetamine 15mg increased from \$2.497/tab to \$4.5480/tab effective 10/11/11.
Nystatin/Triamcinolone Cream increased from \$0.1095/g to \$0.8364/g effective 10/27/11.
